Please be advised that all commercial/industrial uses and businesses within Buckingham Township require a valid Fire Prevention Permit and cyclical inspections. These inspections insure the safety of our community and the firefighters who serve the Township.

In accordance with Township Ordinance #2004-03, adopting the Pennsylvania Uniform Construction Code and the 2003 edition of the International Fire Code, enclosed is the necessary paperwork for filing your required Fire Prevention Inspection Permit. The permit fee is \$55.00, payable to "Buckingham Township."
