**Heritage Conservancy Easement Monitoring Proposal**

Mrs. Cozza said Heritage Conservancy had presented an Agreement for Professional Services to provide baseline monitoring of eased properties within Buckingham Township. She said it differed from the previous agreement in multiple ways, including price, number of properties, and depth of baseline review. Mrs. Rash suggested the baseline review should be conducted before going to settlement in order to provide a true baseline for future comparison purposes. Mr. Smith said some townships attach the baseline review to the conservation easement. The Board asked Mrs. Cozza to evaluate the agreement and present her findings during a future work session.


**Time of October 30, 2019 Work Session**




