Who we are, what we do We are a group of Buckingham residents concerned about the environment of our township, county and the world around us. Like all EACs in Pennsylvania, we serve in an advisory capacity, working closely with our Board of Supervisors as well as neighboring EACs and others to help protect our natural resources and plan for our township's gradual transition to 100% clean, renewable energy. Our activities range from tree-planting projects and nativeplant sales to providing input on invasive species, water issues, grants and sustainable-energy projects.

Perhaps our most important role is to help educate our fellow residents on a variety of environmental subjects. To that end, we provide resource tables at township events, produce flyers on environmental threats (e.g., spotted lantern fly) and create seasonal "tips" sheets (posted on the EAC Page of the Township Website). Clean Energy & Us

On October 28, 2020, Buckingham's supervisors voted unanimously to approve Resolution 2422, "A Resolution Setting Forth the Goals for Buckingham Township to Use 100% Clean, Renewable Energy for All Purposes No Later Than 2050."

Buckingham was the third township in Bucks County to approve such a measure, after Solebury and Doylestown Township. More recently, Warrington and Bucks County itself have approved similar measures, joining some 40 municipalities throughout southeastern Pennsylvania working to meet the climate challenge.

Next up is the creation of an energy-transition plan that works for everyone. This plan will be a perpetual work-in-progress as new technology and opportunities arise. We'll be holding public-input sessions in the future to solicit the thoughts of residents and business owners. Be sure to give us yours!

Landscaping 2.0

Think of your yard as your own personal "Wild Kingdom." It is! Whether you have a fraction of an acre or many acres, your property is home to an astonishing number of wild species, most of them unseen but important to our planet's health nonetheless.

Many people think they have to choose between being "green" and having a good-looking yard. Not so! Whether you're a do-it-yourselfer or work with a lawncare company, consider some "landscaping 2.0" options: replacing thirsty, high-maintenance non-native plants with locals and foregoing weedkiller and dyed mulch.
