Mr. Gray explained this is the Givnish Life Celebrations project which included a parking lot expansion and a building addition for a new space that was completed some time ago. He said there had been landscaping and lighting issues, that have now been resolved with the lighting meeting the approved plan. Mr. Gray explained the applicant had requested that the township waive the Maintenance Period, however he and the Landscape Review Consultant recommend against that, as there had been some landscaping matters that will need to be inspected in September 2024 for a February 2025 or earlier Maintenance security release. Mr. Smith noted the Resolution includes the requirement for the township to be granted an easement for the offsite stormwater facility that was acquired by the funeral home.

He said the delay in requesting dedication was due to paperwork required by the Bucks County Conservation District to get the NPDES permit closed out, which is now concluded. Mr. Gray said he and the Landscape Review Consultant recommend the Board waive the maintenance period for this project. The Board agreed to do so as the project is and has been complete for 18 months, which is the length of the maintenance period.

Mr. Calderaio made a motion, seconded by Mrs. Rash, to approve the "Scardetto Property", Stormwater Facility Development Contract", Permit #PSW190013, 808 Pineville Road, TMP 6-23-55-1, Request for Release #5, in the amount of \$72,658.36 to be reduced by the amount of money currently owed.

Mr. Scardetto argued that he should not be required to keep a \$5,000 minimum account escrow which is noted in the townships' billing. He said he should only have to pay the expenses charged by the township engineer. Mr. Smith reminded Mr. Scardetto that the Stormwater Facility Development Contract with the Township which Mr. Scardetto signed, requires that \$5,000

minimum escrow must be maintained towards costs and expenses until the project is completed, at which point any unused money may be returned. Mr. Scardetto asked that the \$5,000 minimum escrow be waived, as he is under extreme hardship as he owes his contractor money. The Board denied the request to waive the \$5,000 minimum escrow as it is a requirement of the contract, is required of every other development and is a protection to the residents of the township for payment of money owed by the developer in case invoices are not paid.

Mr. Gray explained that the remaining escrow is being held until the driveway entrance is completed, and noted the pipe and final pavement are the only outstanding items. He suggested that requesting a waiver of the final pavement might be considered once the correct pipe is installed. Mr. Gray explained the existing culvert needs to be lowered and built to township standards. Mr. Scardetto said he is being held up because the required headwall has to be custom made and he cannot find anyone to make it. Mr. Gray reminded Mr. Scardetto that Mr. Gray had suggested a flared end section, which would require a longer pipe; a suggestion that was rejected by Mr. Scardetto's engineer. Mr. Gray said that extending the pipe and getting a flared end are standard PennDOT specs. Mr. Gray suggested Mr. Scardetto speak with his engineer and request a polar extension with flared ends.

Mr. Scardetto said he had requested release of the contingency amount, and Mr. Gray explained that amount is released when all of the requirements have been completed per the agreement.

Mr. Forest stated that Mr. Scardetto will be issued the escrow release amount less the amount currently owed. Mr. Scardetto asked for the check, and Mrs. Cozza said it would need to be prepared as she did not know the amount to release until this discussion took place.

The motion carried unanimously.

Mr. Calderaio made a motion, seconded by Mrs. Rash, to approve the "Sycamore Hollow Farms (Histand Tract) – Lot 2", Township File SA 2010-01, Request for Release #12, in the amount of \$0.00.

Mr. Gray explained the reason for a zero amount release is due to the Residential Development Contracts' requirement for the projects NPDES Permit termination by the Bucks County Conservation District and the posting of a Maintenance Deposit prior to the final release of funds. He said the request for release was premature.
