Mr. Calderaio called the regular meeting to order at 7:30 p.m.

## PUBLIC COMMENT

Ms. Stephanie Weisser, Amberton Way, thanked the township for having the well water informational meeting and said that she had learned a lot. Mrs. Rash commended the Buckingham Township Environmental Advisory Commission for their ongoing work to educate our residents.

Ms. Weisser said she saw "volunteers wanted" on the Midway Volunteer Fire Company sign. She questioned if it is difficult to get volunteers, does the township have a plan to change the way the township manages our fire companies. Mrs. Rash responded that the fire companies are not managed by the Township but are independent entities that manage themselves. Mrs. Rash explained the Board of Supervisors have had ongoing conversations and recent meetings with all three fire companies that service Buckingham Township to discuss their budgeting needs and how to address them. The fire companies reassured the township that they are not particularly concerned about volunteerism at this time but are always looking for volunteers for the future. Mrs. Cozza noted that several of the township road crew employees are also volunteer firefighters who respond to calls as needed. Mr. Calderaio pointed out that the tax burden would be exponentially larger if our fire companies were township controlled and paid, not volunteer. Ms. Weisser said this alleviates some of her concerns and she is reassured.

Mrs. Cozza explained that Buckingham Township tried to protect Buckingham Village in years past when several other township historic districts were accepted but were told by the Pennsylvania Historic Museum Commission that there were too many "noncontributing properties" within the Buckingham Village district. Mrs. Cozza explained that recently, while PennDOT was getting clearances for the roundabout project planned at Route 202 and Route 263, they were required to look at the potential historic district due to its proximity, and they redrew the boundaries and removed the noncontributing properties. Mrs. Cozza said that she contacted the Pennsylvania Historic Museum Commission to explain what was happening, and now they are considering approving the newly designated area. Mrs. Cozza explained structures within the historic districts must undergo township review in order to make any changes to the building exterior as seen from the roadway, which provides a level of aesthetic and historical property protection.

#### RESOLUTION NO. 2622

A RESOLUTION OF THE BOARD OF SUPERVISORS, BUCKINGHAM TOWNSHIP, BUCKS COUNTY, PENNSYLVANIA, AUTHORIZING AND APPROVING THE CONDEMNATION OF THE LANDS NOW OR LATE OF PATRICK MCARDLE AND TERESA MARY MCARDLE, h/w BEING BUCKS COUNTY, PENNSYLVANIA, TAX PARCEL NUMBER 6-006-051

WHEREAS, Patrick McArdle and Teresa Mary McArdle are the record owner (hereafter the "Owner") of real property situate in Buckingham Township, Bucks County, Pennsylvania, known as Bucks County Tax Map Parcel No. 6-006-051 (hereafter the "Property"); and

WHEREAS, The Township is authorized by the provisions of Section 2501 of the Second Class Township Code, Article XXV, Section 2501, 53 P.S. § 67501, to acquire by gift, purchase or eminent domain land in fee simple or such other estate or interest as is necessary to establish and construct sanitary sewer systems; and

WHEREAS, the Township requires the fee simple title for the Property in order to expand the Township's spray field capacity on the Property, which spray field will be part of the Township's sanitary sewer system.

WHEREAS, the Township has attempted to negotiate the voluntary conveyance of the Property necessary to expand the Township's sanitary sewer system, without success.

**NOW THEREFORE BE IT RESOLVED** this 28<sup>th</sup> day of February, 2024, by the Board of Supervisors of Buckingham Township, Bucks County, Pennsylvania, at a duly called and convened meeting, that:

- 1. Buckingham Township hereby directs and authorizes the Township Solicitor to file a Declaration of Taking in the Court of Common Pleas of Bucks County based on the provisions of the Eminent Domain Code condemning the fee simple title over the Property as more fully described in Exhibit "A" and as depicted as "Lot 2" on a certain plan entitled Minor Subdivision of Land for Kenneth B. Coles-et ux", as recorded in the Office of the Recorder of Deeds of Bucks County, Pennsylvania in Plan Book 243, Page 8 attached hereto as Exhibit "B".
- 2. The Township Solicitor is directed and authorized to prosecute the eminent domain action unto completion or settlement thereof.
- 3. The Township Manager and one or more of the members of the Board of Supervisors are authorized to execute such documents as are necessary to effectuate the intent of this Resolution and the prosecution of the eminent domain action.
- 4. Buckingham Township further authorizes the payment of necessary expenses in conjunction with the prosecution of the eminent domain action, including the cost of filing fees, expert fees, and other such related costs.
