Mrs. Rash called the regular meeting to order at 6:30 p.m.

Ms. Kelly Whitman from State Representative Tim Brennan's office and Ms. Shannon Sticker from State Senator Santarsiero's office were present to announce that a joint grant in the amount of \$170,000.00 has been awarded to Buckingham Township from the PA Department of Community & Economic Development to fund the Axon Body Camera Program. Chief Scirrotto expressed his appreciation for the support.

Mrs. Rash read a Proclamation of the Board of Supervisors of Buckingham Township, Bucks County, Pennsylvania, Declaring Arbor Day and thanked the Environmental Advisory Committee who have been responsible for receiving grants for hundreds of trees which have been planted in Buckingham Township. She said that the community has been involved in helping to plant the trees, including students of Central Bucks East High School. Mrs. Cozza said the 4th Friday of each April will be observed as Arbor Day, with a special tree to be planted on April 25th and celebrated with a scout troop ceremony.

PUBLIC COMMENT

Ms. Celeste Callahan, Street Road, requested an update on the status of the proposed wastewater sprayfield on land adjacent to her home. Mrs. Cozza explained there has been preliminary soil testing conducted for suitable soils, with planning based upon those tests proceeding and confirmed that Ms. Callahan will be contacted along with other neighbors as the project proceeds into the design phase. Mrs. Cozza said there recently has been litigation initiated concerning the project by Mr. McArdle, former owner of the property, which may cause delays.

Ms. Callahan asked how the township plans to test and address possible PFAS in the water wells. Mrs. Rash explained that the township water system is continuously tested and treated for safety, and said that private wells are up to the homeowner who owns the well to have it tested and treated as they wish. Mrs. Cozza explained that the township has multiple water systems that are treated and maintained according to the required safety standards. She added that the township website has information on PFAS, including information for individual well owners including Pennsylvania approved laboratories for water testing.

Gavin Laboski, Esq. assumed his position as the appointed hearing officer. Mrs. Rash, Mr. Calderaio and Mr. Smith excused themselves from the room.

Mr. Panzer, Esq., representing the Buckingham Township Board of Supervisors, explained that a Hearing Officer can be appointed and serve in one of two roles, fact finder and concluder of law but not ultimate decider OR the Board of Supervisors cedes entire control to the hearing, including decision making authority to the Hearing Officer. Mr. Panzer said the motion in the previous agenda item sounded like the Board moved to have the Hearing Officer actually decide the matter, with the Board of Supervisors waiving the right to make the decision. Mr. Panzer said that in his reading of the Municipalities Planning Code, for that to be valid, the applicant must agree that the Hearing Officer makes the decision in place of the Board of Supervisors. Daniel Lyons, Esq., attorney for the applicant, said he understands that the Board of Supervisors have that authority and on behalf of his client he agrees that Gavin Laboski, Esq. can make that decision.

A court reporter was present and the transcript may be referenced for details of the public hearing.

Mr. Laboski, Mr. Panzer and Mr. Lyons agreed that the record would be held open and the hearing would be continued to the Board of Supervisor's next regularly scheduled meeting on April 23, 2025 at 7:00 p.m. He said there will be no legal notice, advertisement or posting on the property as this announcement is the official notice.
