# Buckingham Township Board of Supervisors Meeting Minutes

The regular meeting of the Buckingham Township Board of Supervisors was held Wednesday, October 22, 2025 in the Township Building, 4613 Hughesian Drive, Buckingham, Pennsylvania.

Mrs. Rash called the regular meeting to order at 6:30 p.m.

#### PUBLIC COMMENT

Mr. Stephen Morrison, Church School Road, said they bought their home in 2019 and had an ongoing water issue which he believed was caused by run off from the Fieldstone development. He said the previous owner had contacted the township many times with no response, however he contacted Mr. Hinz who came out and met with him and his neighbors, and proceeded to clean out the ditch. Mr. Morrison said that Mr. Hinz then returned again and put a curb in front of their driveway. Mr. Morrison gave Mr. Hinz and his crew a big "Atta Boy", adding that they were professional and easy to work with.

Mr. Morrison said the proposed warehouse followed by the new announcement of the land being a housing subdivision was some weird crap going on with somebody on this panel making an announcement that the warehouse was no longer a problem. He said he was very disappointed in this board.

Ms. Sarah Cohen, South Deer Run Road, said she lives ½ mile from the proposed spray field near Mechanicsville, and has ongoing concerns about PFAS exposure and how the effluent may impact and add contaminants to the groundwater. She appreciated the PFAS remediation article in the township newsletter, and asked if that meant the water for all the effluent would be pre-treated prior to application on active spray fields? Mrs. Cozza replied the article in the newsletter regarded remediation for public drinking wells, adding there is no treatment required presently for PFAS in wastewater effluent applied to spray fields.

Mrs. Cozza said she is meeting with the townships Environmental Advisory Commission next week to help plan an educational meeting on spray fields, and the educational meeting will have experts available to answer questions. She explained the township does not have the power to oversee private wells, but is mandated to oversee public systems by the PADEP.

Mrs. Stephanie Weisser, a member of the Buckingham Township Environmental Advisory Commission advised Ms. Cohen that she could put filters on her drinking water taps for very little money to reduce exposure to PFAS.

Ms. Cohen requested that the township extend PFAS testing to include private well users, clearly disclose what locations are being tested, release all engineering reports and provide a timeline for community engagement before finalizing sprayfield expansions.

Ms. Celeste Callahan, Street Road, provided the Board with a document titled "Groundwater Risks from Wastewater Spray Irrigation in Buckingham Township, PA". Ms. Callahan had specific questions about the upcoming hydrogeologic study regarding the acquifer underneath the proposed spray field, and Mrs. Cozza asked her to supply her with those questions.

Ms. Callahan asked if there will be buffer zones around the perimeter of the spray site to protect those who are nearby? Mrs. Cozza replied "yes", adding that the monitoring wells placement will be outside of where you would think the spray field will be, adding that there are also requirements for the distance of spray to properties.

Ms. Diane Treat, Mechanicsville Road, explained their home is in the middle of the proposed sprayfield and they feel incredibly vulnerable. She said they have several gardens with multiple sitting areas that they enjoy, and have a private well and private sewage system. She has concerns about aerosol from the sprayfields blowing onto her property, and asked if that has been tested as the wind usually blows a lot in her area. Mrs. Cozza replied the spray does not leave the property as there are buffers planted.

Ms. Treat said there were 6 wells dug on the spray field property but the township did not tell her about that, she learned it from her neighbor. She asked why one is only 185 yards from her property line, and what are they for. She asked if she can get test results each time without filing a right to know request, and Mrs. Cozza said she could. Mrs. Cozza explained the wells were dug and the township is getting the first baseline test results from the hydrogeologist, adding that there is no spray field plan prepared yet and that Ms. Treat will have input in that process.
